

A NOTICE AND INVITATION TO ALL EMPLOYEES AND APPLICANTS EQUAL OPPORTUNITY AND AFFIRMATIVE ACTION POLICY STATEMENT

Kaman Corporation has been and will continue to be an equal opportunity employer. To ensure full implementation of this equal opportunity policy, we will take steps to ensure that:

INVITATION TO COVERED VETERANS TO SELF IDENTIFY
